

**ADDITIONAL INFORMATION FOR ADMISSION INTO THE  
M. PHARM. COURSE AT DIBRUGARH UNIVERSITY,  
SESSION 2012-13**

Candidates should pass 4 years B. Pharm Degree Examination with minimum of 55% marks from Dibrugarh University or from any other University recognized by the Dibrugarh University and AICTE/PCI

1. Preference will be given to valid GPAT qualified candidates.
2. Candidates seeking admission against seats reserved for S.C./ S.T must submit certificates of cast issued by the Competent Government authorities (not by any organization.)
3. Applications must be accompanied by attested copy of certificates and mark sheets of all examinations passed, and cast certificate.
4. **Incomplete or late receipt of applications will be rejected.**
5. Selected candidates will be called for counseling at the Department of Pharmaceutical Sciences, Dibrugarh University. No. TA/DA is admissible for the purpose.
6. Finally selected candidates must take admission on the date to be specified by the Department.
7. Hostel seats may be available only after the Final semester examinations of the current batch of students.
8. The course fee is Rs. 50,000.00 (Rupees fifty thousand only) **per semester** in addition to admission fee approx. of Rs. 5000.00 (Rupees five thousand only) which may be revised by the University from time to time.

**Rules for admission of sponsored candidates in M. Pharm Course:**

- i) Candidate must possess the minimum prescribed qualification and should be in service in a Government organization/established research and development organization/ autonomous public undertaking/ universities or recognized technical institution.
- ii) Candidate must have at least 2 years of experience in service after graduation.
- iii) Intending sponsored candidates must submit their applications on prescribed form and should be accompanied by the letter of sponsorship from competent authority of employing organization.

1. Candidates seeking admission into the course against the seats allotted to Assam must be permanent resident of Assam (P.R.C. must be enclosed)
2. Candidates seeking admission against seats reserved for S.C./ S.T must submit certificate of cast issued by the Competent Government authorities (not by any organization.)
3. Application must be accompanied by attested copy of certificates and mark sheet of examination passed and cast certificate.
4. Incomplete or late receipt of applications will not be entertained.
5. Selected candidates will be called for counseling at the Department of Pharmaceutical Sciences, Dibrugarh University. No. TA/DA is admissible for the purpose.
6. Finally selected candidates must take admission on the date to be specified by the Department.
7. Hostel seats may be available only after the Final examinations of the current batch of fourth year students.
8. The tuition fees per annum will be around Rs.5,500/-(Five thousand five Hundred only) which may be revised by the University from time to time.
9. For the endowment seats the course fee is 45,000.00 (Rs. Forty Five Thousand only) **per year** which also may be revised by the University from time to time.
